

Court Of Appeal Dismissed Appeal by Hamilton Against Judgment Of 15 June 2021

On 23 June 2021 Hamilton lodged an appeal against the judgment of the District Court of Amsterdam dated 15 June 2021 concerning applications filed by Hamilton. Hamilton withdrew its appeal on 5 July 2021. Consequently, the Amsterdam Court of Appeal dismissed Hamilton's appeal.

2.1. Nu Hamilton c.s. het hoger beroep hebben ingetrokken, kunnen zij niet in hun beroep worden ontvangen.


2.2. Op grond van hetgeen onder 2.1 is overwogen, beslist het hof als volgt.

3. Beslissing


Het hof:

1. The proceedings on appeal

The appellants are hereinafter referred to as Hamilton et al.; the respondent is hereinafter referred to as Steinhoff.

By notice of appeal received at the Registry of the Court of Appeal on 23 June 2021, Hamilton et al. appealed the decision rendered by the Amsterdam District Court on 15 June 2021.

1.2 The appellants withdrew their appeal through a V4 form dated 5 July.
The respondent informed the court by e-mail dated 6 July 2021 that it agreed to the withdrawal.

2. Assessment

2.1 As Hamilton et al. have withdrawn the appeal, they cannot be admitted in their appeal.

2.2 On the basis of the findings in para. 2.1, the Court of Appeal rules as follows.

3. Decision

The Court of Appeal:

- declares the appeal lodged by Hamilton et al. inadmissible.
